

**“Big Little Road Trip” PROMOTION**  
**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 33 Alfred Street, Sydney NSW 2000 AUSTRALIA 02 4261 8148 (“**Promoter**”).
3. Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
4. Employees (and their immediate families) of the Promoter, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
5. This promotion will be conducted at DAPTO MALL, 75 PRINCES HIGHWAY, DAPTO, NSW (“**Centre**”).
6. Promotion commences on Tuesday 6 April at 9am and ends at 5pm on Sunday 18 April 2021 (“**Promotional Period**”).
7. To enter, individuals must complete the following steps during the Promotional Period:
  - a) Scan any of the eight (8) QR codes on the marked floor decals at Dapto Mall.
  - b) Upon scanning the QR code, the individual will access the competition web app, where they are given instructions to locate and scan any and / or all the floor decals Dapto Mall.
  - c) Each scanned floor decal will display an augmented reality landmark. The individual is required to tap to activate the landmark and earn tokens.
  - d) The number of tokens earned increases per scanned decal and activated landmark.
  - e) Each token won acts as an entry into the prize draw. The more tokens an individual has, the more chances they will have to win a/ the prize(s).
  - f) To be in the draw for a chance to win a/ the prize(s), the individual must complete the entry form during their Big Little Road Trip adventure. The individual can continue to play and earn tokens after registration.
  - g) An individual can play multiple times across multiple days, but only scan each decal and activate the landmark once per day.
8. Incomplete, indecipherable, or illegible entries will be deemed invalid. Multiple entries permitted, subject to the following: (a) each entry must be submitted separately and in accordance with entry requirements.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

10. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
11. The draw will take place at DAPTO MALL, 75 PRINCES HIGHWAY, DAPTO, NSW on 23 April 2021 at 12.00pm (“**Draw**”). The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. An entrant does not need to be in attendance at the Draw in order to win a prize.
12. Winner(s) will be notified by email within two (2) business days of the Draw.
13. The Promoter’s decision is final and no correspondence will be entered into.
14. The first valid entry drawn will win a Big W Gift Card, valued at \$250. The next five entries drawn will each win a Big W Gift Card, valued at \$50 each.
15. If a winner is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner’s behalf.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a prize.
