

“DAPTO MALL WIN TICKETS TO JAMBEROO ACTION PARK” PROMOTION
TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 33 Alfred Street, Sydney NSW 2000 AUSTRALIA telephone (02) 4261 8148 (“**Promoter**”).
3. Entry is only open to residents of the Illawarra Shoalhaven region. For the avoidance of doubt, the Illawarra Shoalhaven region is defined as stretching from Helensburgh in the north to North Durras in the south. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.

7. To enter, individuals must complete the following steps during the Promotional Period:
 - a) Complete the online entry form to subscribe to the Dapto Mall email newsletter
 - b) Be a current subscriber at the time of the draw
8. Incomplete, indecipherable, or illegible entries will be deemed invalid.
9. Only one (1) entry permitted per person.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. An entrant does not need to be in attendance at the Draw in order to win a prize.
13. The Winner will be notified by email within two (2) business days of the Draw.
14. The Promoter’s decision is final and no correspondence will be entered into.
15. The first valid entry drawn will win four (4) General Admission Tickets to Jamberoo Action Park, valued at \$280.
16. The following conditions apply to the prize(s): Valid any single open day during Jamberoo Action Park’s 2021/2022 Season up to 25 April 2022.

17. If a winner is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner's behalf.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a prize.
